<u>Bangladesh Bank (FE) Circular no 31, on Encashment Certificate Against Inward</u> <u>Remittances on Account of Information Technology Enabled Services (ITES) Exports,</u> <u>Dated 16 November 2022</u>

Bangladesh Bank has allowed mobile financial service providers to repatriate (conversion of foreign currency into local currency) export income and inward remittance. All authorized dealers will provide encashment certificates to MFS providers against inward remittance, on account of information technology-enabled services exports. Read More

<u>Parliamentary Amendment on Bangladesh Atomic Energy Commission 2017, Dated 20 November 2022</u>

Aiming to change the names of two posts in the Bangladesh Atomic Energy Commission, government gas amended the law name to Bangladesh Atomic Energy Commission 2017. According to the amendment, if there is any post called Assistant Secretary, Deputy Secretary, Additional Secretary, and Secretary in any office under any ministry or division, the name of the post has to be changed. Hungary

Hungary Has Given In: The Global Minimum Tax Is Coming to the Union

In October 2021, along with 136 states, Hungary joined the countries that signed the OECD's international tax reform plan. Soon after that, in December 2021, the OECD Model Convention on the Global Minimum Tax and the draft EU directive came out, within a few days of each other. It therefore caused quite a stir when, at the meeting of EU finance ministers in June this year (the ECOFIN meeting), the Hungarian government unexpectedly announced that it did not support the adoption of the directive because it would lead to tax increases, a deterioration of Hungarian competitiveness and, overall, a loss of jobs in Hungary. Stricter Transfer Pricing Rules Were Published

On December 28, 2022, an amendment to Decree No. 32/2017 (X. 18.) of the Ministry for National Economy on the Documentation Requirements Pertaining to the Determination of the Arm's Length Price was published in the Hungarian Official Journal. The TP Decree entered into force on December 31, 2022. The new rules are already in part applicable to the intra-group transactions of 2022. Read More
