NCLTs and NCLATs Have the Power to Recall Their Judgments

The National Company Law Appellate Tribunal, Principal Bench, New Delhi held that the National Company Law Appellate Tribunal can recall its judgments by virtue of the inherent power vested in it under Rule 11 of the National Company Law Appellate Tribunal Rules, 2016, in case of a procedural error while delivering the earlier judgment. Madras High Court Rejects Enforcement of a Foreign Arbitration Award Which Was Passed Without Considering Violations of Foreign Exchange Management Act, 1999 and Fraud in Share Valuations

The Hon'ble Madras High Court has rejected enforcement of a foreign arbitration award on the ground that it was passed without considering the fraud and violations of regulation of the Foreign Exchange Management Act, 1999, which were not curable. Read More

NCLT Hyderabad Rejects Resolution Plan For Being Incompliant with Regulation 36B 4(A) of the CIRP Regulations

The National Company Law Tribunal, Hyderabad has rejected the resolution plan approved by the committee of creditors on account of non-compliance with Regulation 36B (4A) of the Insolvency and Bankruptcy Board of India (Insolvency Resolution Process for Corporate Persons) Regulations, 2016, since the performance bank guarantee submitted by the resolution applicant expired prior to the duration of the plan implementation schedule.
